It was commented that mediation was a useful process bringing together the dispute parties to sit face-to-face for discussion.

The mediator understood each other's underlying interest, skilful in breaking through impasses, making a conscious effort not to dwell with matters in the past. He perused what was important at hand.

It was mentioned that the mediator displayed great amount of patience and persistence in handling the situation objectively as an impartial facilitator, he engaged and ensured parties air their concerns by allowing many rounds of caucuses also the use of different languages and spoken dialects.

However, in conclusion the writer felt that mediation will only work with both parties in an open mind and willing to come together.
