On 25 September 2022, the International Institute of Mediators (iiM) partnered Fernvale Mediation Centre (FMC) in a joint effort to encourage residents to adopt amicable methods of resolving disputes that may occur in the community and neighbourhood. The Fernvale Community Club was officially opened by Prime Minister Lee Hsien Loong on 25 Sept 2022 where the FMC is located.

The iiM provided an educational seminar followed by a two-day training on mediation to members of FMC, who will refer cases of disputes for iiM's facilitation.

UPCOMING COURSES



Conflicts occur in every situation where interaction occurs and for a variety of reasons.

This 40-hour accreditation programme is designed with both practice and theory to help participants understand why conflicts occur, and how they can deal with them in an amicable manner using mediation. The skills acquired may be applied for resolving commercial, social, or other types of disputes.

It will equip participants with the necessary skillsets and competence to mediate disputes in their respective fields and cross-border conflicts.

Programme Outline

- Introduction to Mediation in Singapore
- Mediation Concepts, Principles and Process
- Mediation Techniques and Skills
- Cultural Influences and Awareness
- Role Play and Coaching

Learning Objective

Participants will acquire skills in dealing with conflicts in different contexts. The purpose is to equip them with skill sets that they use to analyse and resolve such conflicts. They will have the opportunity to experience how to handle such conflicts in role plays and simulations.

Fee: S\$2,450 (GST not applicable) per participant. *Registration on a first-come basis with full payment.*

Learning Outcome

This course hopes to produce a peaceful and harmonious environment where organisations and the community can use the acquired mediation skills to resolve problems that occur in their respective environment. They will be able to recognise the impact of cultural influences in cross-border disputes.

Anyone who wishes to learn more about the skills and techniques that can be used to help them resolve conflicts with their colleagues, neighbours, friends, or organisations.
